*Another year has passed, during this year our integrated activities both in the Healthcare and Education sectors have given us enough experience, immense pleasure and an added enthusiasm to perform even better.*

*This year, at “ Sanjeevani Health Care Unit “ over 100 free corrective operations of the congenital physical disabled children (Divyang) has been done from all over the State. Since the beginning, in totality we have performed over 600 free operations of (Divyang) and tried to bring them back to mainstream. Additionally Physiotherapy, Yoga & Music Therapy are provided which help them to recover and rehabilitate faster.*

*We have done quite a lot of development work at our School, “Sanjeevani Bal Vidya Mandir” at Suarsoat, Dist: Sonbhadra. This year we have planted around 60 fruit trees like Mango & Guava etc. at the campus. Constructed another floor, developed a playground and did barbed-wire fencing of the boundary. Now we are trying to improve & upgrade the Computer Education Programme also.*

*Our unit at New Delhi “Aashirwad Special Education School “ have organized many social activities. Among them Social Awareness on AIDS, Women Empowerment with Vocational Training and above all Special Education to the marginalised children through Physiotherapy, Speech & Music Therapy & Yoga also.*

It was once again a year of hectic journey and as an organization, it was our endeavour to make greater meaningful role to all the Stakeholders.*

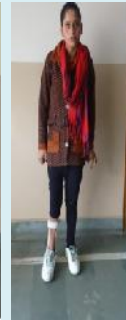
